When can I enroll?

There is no enrollment period. Apply any time.

Who can enroll?

US citizens and qualifying immigrants who meet income requirements.

How do I keep my coverage?

Remember to renew every year. A reminder is sent through the mail 45 days prior to the deadline.

What does it cover?

Prescriptions, hospital care, doctor visits, emergency visits, vision care and glasses, substance abuse treatment, maternity and newborn care *and more*.

When can I enroll?

Open enrollment is between November 1 - December 15. You can also enroll within 60 days of a Special Life Event. Examples of this include; loss of health insurance coverage, changes in household size and changes in income.

Who can enroll?

US citizens and qualifying immigrants.

How do I keep my coverage?

Renew your coverage during open enrollment by visiting healthcare.gov or by calling the Marketplace at 800.318.2596.

What does it cover?

Each plan has different premiums, deductibles, copays, coinsurance and scopes of coverage.

Will I get a tax credit?

Depending on your income you may be able to receive tax credits that will help you pay for some or all of your monthly premium.
